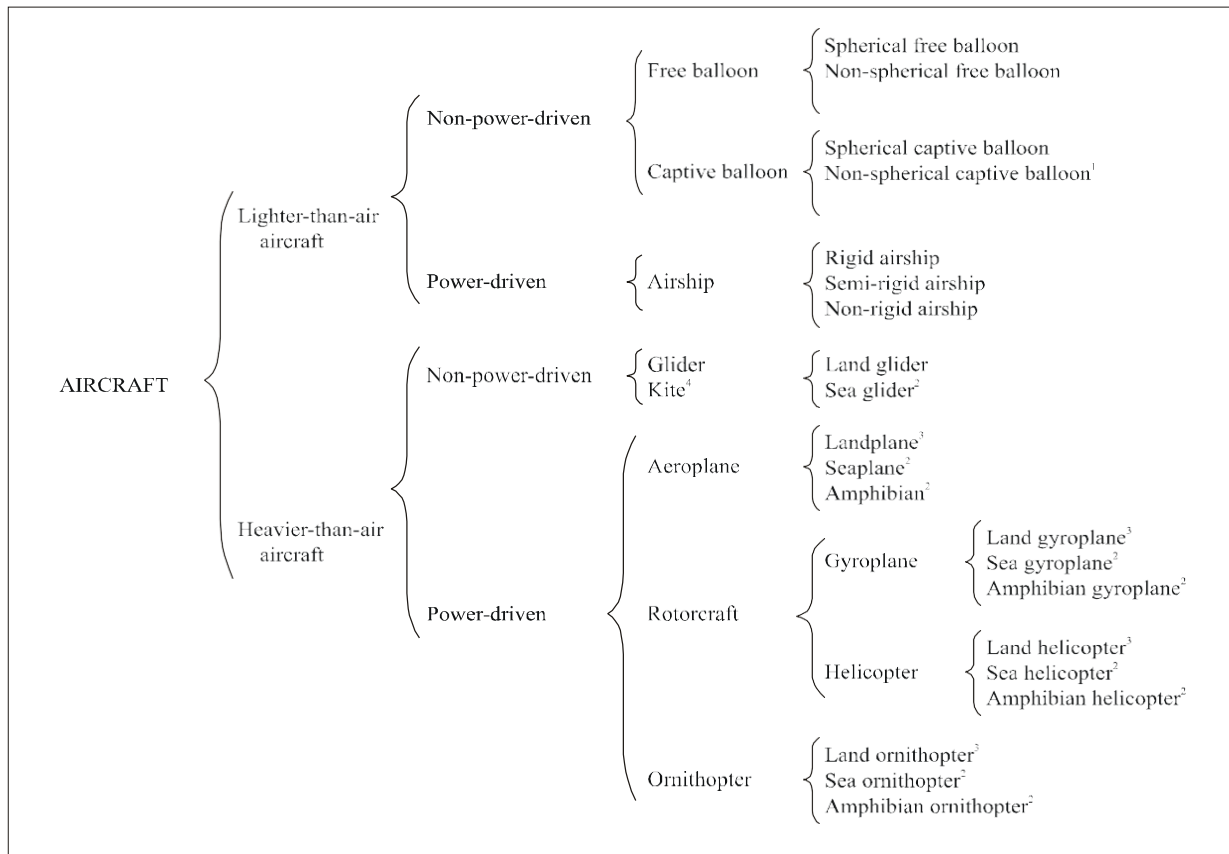

Notes to be read when completing this application form

1. If the aircraft is to be registered in the name of an unincorporated body or more than one individual the full names and address of all persons sharing the ownership should be given. In the case of an unincorporated flying group shoes assets are held by trustees, the names and addresses of all members of the group. In the case of an aircraft chartered by demise and registered under the Air Navigation Technical Regulations (ANTR), the name and addresses of the charter should be given.
2. A club or Hotel should not be given as the address unless the applicant resides there permanently.
3. The Register of Aircraft is available to the public and includes the names of the registered owners of aircraft and their addresses.
4. The Owner or Charterer should sign personally;
Where more than one person is shown as owner (See Note (1)) each person should sign. In the case of Corporate Body or Undertaking, a Director, Secretary or other authorised officer of the company should sign, stating the position he holds, and a covering letter should be attached to the application giving names of all such authorised officers.
5. The attention of the applicants wishing to register aircraft is drawn to the Civil Aviation Law and ANTR.
6. The attention of all persons completing and signing this form is drawn to the importance of ensuring that the entries are correct. The making of a false statement for the purpose of procuring the issue of Certificate of Registration is an offence under the Civil Aviation Law.
7. Submission of other applications, such as application for Issue of Certificate of airworthiness, Operations Approvals, Special Operations Approval, AOC issue or amendments etc. may be done simultaneously at the appropriate time when compliance to the respective regulations established.

Table A General Classification of Aircraft according to the Air Navigation Technical Regulations (ANTR PART-V)
