### GUIDELINES FOR FILLING THE NOC APPLICATION FORM FOR CONSTRUCTION OF HIGHRISE STRUCTURES IN THE KINGDOM OF BAHRAIN

The application completed in all respects should be submitted to the Director of Aviation Safety & Security, Civil Aviation Affairs, P.O. Box 586, Kingdom of Bahrain.

The location plan of highlighting the site of proposed structure with reference to the airport concerned and duly approved and authenticated by the municipal authorities / Urban Development authority / any other authorized agency.

Architectural drawings of plan and elevation including site plan with dimensions of the proposed structure or alterations clearly indicating the heights above the ground level and mean sea level.

A certificate authenticating the site elevation from the Municipal authorities / Survey Directorate.

The following undertakings are to be submitted in the prescribed Performa.

1. Undertaking for not installing any superstructures above the duly authenticated submitted drawing, not commencing construction on the proposed site before grant of NOC and for not making complaints / compensation demands against aircraft noise, vibrations, damages etc., due to aircraft operation at and in the vicinity of the airport (Form - IA).
2. Undertaking for not causing smoke hazard, if the application is for industrial units / factory / chimneys (Form - IB).

If the application for NOC is for alterations / modifications of existing structure, a copy of earlier NOC for original structure is to be enclosed.

The sectional and elevation drawings should include all installations planned above the structure such as radio / television aerial / mast, lightning arrester, vent pipes, overhead water tanks and attachments on superstructure of any description.
